## **Waiver of liability in favor of Motopark Racing UG, its contractual partners, its subsidiaries and its branches, including the employees, helpers and other vicarious agents working for them in each case**

### **1. type of event:**

Race training on a track that is closed to public traffic (circuit), but where an increased accident risk is to be assumed due to the track condition and the speed driven. The event is not intended to achieve maximum speed and, despite its name, has no competitive character and is not intended to record the shortest driving time. Competitive driving between the participants of this event is prohibited.

### **2. conditions of participation:**

All registered participants are eligible to participate (driver - minimum age 14 years, up to the age of 18 years but only with written consent of the parent or guardian) with vehicles which must be in a technically faultless, race worthy condition. The driver insured to be the holder of a valid racing license (karting or racing) and must be able to present this on request. The driver declares by his following signature that he is the owner of the vehicle or he has a written power of attorney from the owner, which allows him to use the vehicle within the scope of this event.

### **3. disclaimer of liability:**

- a) The participants (in particular driver/team/vehicle owner/operator) take part in the event at their own risk. You accept full civil and criminal liability and responsibility for all damage caused by you or the vehicle you use. Drivers/teams are liable for their guests and helpers.
- b) By signing this declaration below, the participants declare that they waive any claims for damages of any kind arising in connection with the event, namely against Motopark Racing UG, its contractual partners, its subsidiaries as well as branches including the employees, helpers and other vicarious agents working for the aforementioned. This includes, but is not limited to, the race track operator, sports control room, authorities and other persons commissioned with the execution and organization of the event. Similarly, co-drivers waive claims against the driver.
- c) The waiver of liability does not apply to damages resulting from injury to life, body or health or to other damages which are based on an intentional or grossly negligent breach of duty by a legal representative or vicarious agent of the group of persons released from liability.
- d) The liability of the participants (on the course) among each other is excluded, here a waiver of liability is considered as agreed. Excluded from this is intent and/or gross negligence. The participants undertake to compensate the injured party for any damage they have culpably caused during the event on the premises of the event or with other participants or their vehicles and to settle this directly with the injured party or via their own liability insurance.
- e) Tacit exclusions of liability shall remain unaffected by the above liability waiver clauses.



#### 4. other provisions:

- a) The customer is responsible for his own property or objects provided and there are no claims for loss, theft and damages - not even if Motopark Racing UG has taken objects of the customer into its care for temporary storage.
- b) It is essential that the instructions of all persons responsible for organizing and carrying out the event are followed.
- c) If the number of participants is too small, the organizer is entitled to cancel the event. Any participation fees paid will be refunded to the participants, further claims (such as the entitlement to loss of income) cannot be asserted from the cancellation of the event.
- d) During the event, Motopark Racing UG has the householder's rights on the premises of the event and can immediately ban such participants from the event if the participant contravenes existing and agreed rules of conduct and safety. There is no right to a proportional or complete refund of the participation fee or any other costs (for example, travel, accommodation, personnel costs).
- e) The participation in the driver's briefing which is announced before the beginning of the event by announcement in the "Event-Info" with place and time, is obligatory for all participants.
- f) The participant agrees to photo, sound and film recordings during the event as well as to their free use within the scope of publication by Motopark Racing UG, its subsidiaries and branches as well as your contractual partners.

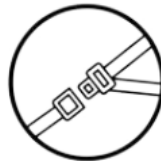

Überholverbot – Gefahr – langsamer fahren  
No overtaking – danger – drive slowly



Unterbrechung des Events. Langsam – max. 80 km/h – zur Boxe zurück fahren. Überholverbot! Zum Anhalten bereit sein!  
Interruption of event. Slowly – max. 80 km/h – drive back to the pit area. No overtaking! Be ready to stop!



Rutschige Fahrbahn. Überholen ist weiterhin erlaubt. Bei nach OBEN gezeigtem Finger: einsetzender Regen.  
Slippery road surface. Overtaking is still allowed. With finger pointing upwards: incipient rain.



Schnelleres Fahrzeug folgt und möchte ggfs. überholen.  
Faster vehicle follows and wants to overtake if necessary.

We expect considerate behaviour among participants on and off the track. Driving and overtaking manoeuvres that endanger other participants are prohibited.

In case of misconduct, the participant may be excluded from the event. There is no entitlement to a refund of participation fees paid or any other costs.
